ABOUT OUR PLENARY SPEAKERS

PROFESSOR GEORGE ANNAS JD, MPH, Department of Health Law, Bioethics & Human Rights Boston University School of Public Health. Professor George Annas is an internationally recognized scholar in health law, bioethics, and human rights. He has written or edited dozens of books in these fields and has written a regular feature writer on *Legal Issues in Medicine* with the New England Journal of Medicine. Professor Annas is the cofounder of Global Lawyers and Physicians and often referred to as the “father of patient rights”.

VIVIEN BURT MD, PhD, Professor of Psychiatry at David Geffen School of Medicine at UCLA & Founder and Director of UCLA Neuropsychiatry Institute & Hospital, Women's Life Center. Dr. Vivien Burt received her Master's in Physiology and Biochemistry as well as a PhD in Physiology from Rutgers University in New Brunswick, New Jersey. She then did a Post-Doctoral Fellowship in the Division of Hematology and received her medical degree at McGill University in Montreal, Quebec.

HANI ATRASH MD, MPH, Associate Director for Program Development, National Center on Birth Defects and Developmental Disabilities, Center for Disease Control and Prevention. Dr. Atrash is an Obstetrician/Gynecologist with training in Epidemiology and Preventive Medicine. Dr. Atrash

is the Temporary Adviser to the World Health Organization, holds an academic appointment as the Clinical Associate Professor at the Emory University Rollins School of Public Health. He is the author of 130 scientific articles in peer review journals, reports and book chapters.
